#### An Editorial Comment by Pat Wainwright

I am sitting here in my RV in Anthem, Arizona, reading this morning's copy of the Arizona Republic. Even though it is part of USA today it is not a bad newspaper. The headlines today, as they have been since election day addresses voter fraud in Arizona. It could better be framed as crimes against republican candidates by county clerks. Today's is "Democrats optimistic after big gains in the recount".

As a voter judge in La Plata County, trained by the best, Linda Gray and Tiffany Lee Parker, I cringe when I see the newspaper photos and TV coverage here about how the ballads are being handled in Arizona. There are many opportunities for fraud and many are being taken. The Dems have come up with 95,000 ballads that were not present on election day. So where did they come from? Strange.

Even stranger though is the defeat of the current Colorado Secretary of State Wayne Williams. As stated by FOX news after researching all states, Colorado is the best state for election procedures and elections. Members of CFRW gathered at the Doubletree Hotel in Westminster September 29-30, 2018 to commemorate the **80**<sup>th</sup> Anniversary of the Colorado Federation of Republican Women (CFRW). In 1938, in Chicago, Illinois, a group of Republican women lead by Joyce Arneill founded the National Federation of Republican Women (NFRW). Here in our wonderful Colorado the basis of what was to become the largest national political group of women was formed. Joyce Arneill became the first president of CFRW and NFRW.

The organizers of the fall convention selected "Pearls and Pachyderms" as the theme which was reflected in published materials, decorations, banners, and a cake served Saturday afternoon. A commemorative pin was designed and given as a gift from President Marilyn Harris to all attendees of the convention.

Several political candidates were invited to formally speak or dropped by to speak to the group. One of the special speakers was Jim Arneill, the grandson of Joyce Arneill, who gave a touching summary of his grandmother's life. Cake baker Jack Phillips and his attorney spoke of his supreme court case, his financial cost, and the two court cases now pending. While his decision not to bake a wedding cake for a gay couple has been upheld by the courts, the cost has been devastating.






#### MONTROSE COUNTY REPUBLICAN WOMEN

#### Colorado Federation of Republican Women (CFRW) The Dulany Woodward Educational Grant Application

The CFRW "Dulany Woodward Educational Grant" is administered by CFRW in the following manner:

- A. The CFRW Dulany Woodward Educational Grant is administered by the voting members of the CFRW Executive Committee. The CFRW President appoints the Chairman.
- B. The criterion is established by the Grant Committee and is inscribed on the application.
- C. The Chairman is responsible for:
  - 1. Distribution and receipt of applications;
  - 2. Conducting meetings for application review;
  - 3. Reporting the recommendations to the President for notification by the President to the Executive Committee and recipient (s); and
  - 4. Keeping the names of the applicants confidential.
- D. CFRW does not discriminate on the basis of race, religion or national origin in the awarding of the Financial Aid Program.

The Criteria for the CFRW "Dulany Woodward Educational Grant" Applicants are as follows:

- 1. Must be an active member of a CFRW Club
- 2. Must demonstrate an involvement in the Republican Party and there must be an indication of continued involvement.
- 3. Be awarded only one time per year with a maximum amount of \$100
- 4. Cannot be used for Republican Fundraising or campaign events
- 5. This program is limited to Republican sponsored events such as CFRW and NFRW meetings, Leadership Program of the Rockies, Republican National Committee events, Lincoln Club, Capitol Club, Colorado Assembly cost, etc.
- 6. Application must be submitted at least 30 days prior to event.

All information in this application is considered confidential and shall be treated as such.
