

*Thank you* to the club treasurers who have sent their initial membership rosters, membership fees, and NFRW service fees. Your efforts help keep your clubs in good standing. You may send additional member information and their dues as you receive them.

Clubs who have not sent these initial reports are now delinquent. It is important that you submit the \$15.00 NFRW club service fee and initial member roster as soon as possible.

As a reminder, your membership roster should be typed, clearly formatted, alphabetized by last name and contain the following information:

- 1. The FULL name of the club, no initials
- 2. Club president's name and contact information
- 3. Treasurer's name and contact information
- 4. Each member's name, address, phone number, and e-mail
- 5. Only regular memberships are required to be reported

An excel spreadsheet works very well if you are comfortable using this format. However, well formatted text programs are also fine. Most important is clarity and inclusion of all required information. If you need help with formatting, please contact me by email or phone as listed below.

Your roster may be emailed, but you must mail:

- 1. A printed copy of your roster,
- 2. Your check for membership dues of \$15.00 per member, and
- 3. A separate check for the NFRW club service fee of \$15.00 per club per year.

NOTE: The CFRW convention delegate allocation for each club is based on the paid memberships as of May 30. Delegates to the NFRW convention must have been members in good standing for at least six months prior to the convention.

DONATIONS to the CFRW Scholarship Fund, and to the Dulany Woodward Educational Grant Fund may be made at any time. Mail to the CFRW Treasurer.

#### Jan Gardner, Member-at-Large, Awards

Dear Club Presidents and District Directors,

If you do not know me, I am Jan Gardner, member of the 4 Corners Republican Women's Club (4CRW) in Cortez, CO. I have been a member of a CFRW club since the mid-90's--shortly after moving to Colorado and am currently serving as President of 4CRW. I was elected to Member-at-Large at the 2017 Fall Convention of CFRW last October. I am excited about serving all of you through CFRW.

**Club Achievement Award:** At first glance, it looks overwhelming because it is 9 pages long! But, at closer look, just read down the pages, record the number of points for things your club has completed in the given 2-year period, total them and BOOM--you've qualified for an award!! But be sure to mail your application into our State President by the deadline (usually June first)! Then, she signs off and mails it to NFRW. **Campaign Volunteer Award:** Again, a 2-year reporting period, you need to keep track of campaign-related volunteer hours. There is a written policy as to what can be counted, The easiest way for members to keep track would be to record on/in their calendar/day-tracker/etc., and then report monthly to a designated club member for tracking. Again, this award needs to be reported to the State President by June 1st to qualify. This one is for club & state at the National level...at the individual level within our state, I hope to work on an award for the individual with the most campaign volunteer hours. I hope to have information on that at the Spring Board Meeting in March.

*Membership Incentive Awards:* This one is a one-year award for clubs and members that recruit the most members--and this one has some **ca\$h** awards as well! Your membership chair could easily keep track of this one, fill out the application and send to the State President by June 1st. There are 4 categories to consider so check it out and apply! This one has individual, club and state levels of award.

*Caring for America Award:* This is also a one-year award and one you can identify and be credited for your community service--there are even some ideas on a page in this section! Again, due to our State President by June 1st. This one, at the National level is designed to award the club and State levels. Perhaps we can design something at the State level to award an individual...I will see!

Behind the awards, are the guidelines for 2 scholarships and an internship. Please read through these--they are probably pretty competitive to receive, but if you or someone you know would qualify to submit an application for consideration, you don't know unless you try!

I think it is safe to say we all know we all do a LOT of campaign volunteering, community service and do our best to recruit members...and although we do not do it for the recognition, it is nice to be recognized once in a while. It is CFRW's 80th Anniversary, let's consider 2018 the year to <u>*roar*</u>-let NFRW hear from the Colorado Republican Women via our submissions that document all we do and have done!

I look forward to working with you on Awards. Please feel free to contact me if I can be of any help. I also look forward to seeing you at the spring meeting in March! Bring questions if you have them and we will try to answer them--if we don't know the answers, we will get them!

#### Jan Cummings, District Director, District 5



#### Lois Landgraf, Legislative Chairwoman

January 10<sup>th</sup> was the opening day of the 2<sup>nd</sup> regular session of the 71<sup>st</sup> general assembly. And since then things have been hopping.

As of January 28, there had been 145 bills introduced in the House and 105 in the Senate. Everything from the allowable uses of reclaimed domestic wastewater to flush your toilet to bills for veteran's services and human trafficking. One bill that will be of interest to all of you is SB 18-061, a Grantham-Sonnenberg, Lawrence-Landgraf bill that will reduce the state income tax rate from 4.63% to 4.43%.

Representative Liston has made it his mission to stand up front every day and report on the positive impact the Trump tax cuts are having on Colorado. This "fresh off the news" information isn't all that well received by the Dems. (too bad!)

In case you are wondering, the sexual harassment issue seems to have quieted down. There is training going on but no one has been voted out of town. There doesn't seem to be a new process in place for reporting such egregious behavior. Nothing seems to have really changed other than people being a little more guarded in their behavior and lots of questions (jokes?) as to whether that hug constitutes harassment.

The biggest debate at the Capitol is on transportation. The big issue with transportation isn't about the number of lanes to be added or to toll or not to toll, the big debate is how to pay for it. There are those at the Capitol who believe there is money in the budget to cover our transportation needs. And there are those who believe the real answer lies in raising taxes. There are also people in the middle who think asking our citizens for permission to procure bonds, without raising taxes, is the real solution. Senate bill 1 does exactly that. **SB18-001, Transportation Infrastructure Funding** requires the transportation commission to submit a ballot question to the voters at the November 2018 general election. If approved, this bill will authorize the state, with no increase in any taxes, to issue additional transportation revenue anticipation notes for the purpose of addressing critical priority transportation needs and it would require ten percent of state sales and use tax net revenue to be credited to the state highway fund for the purpose of repaying any notes issued and funding transportation projects. This bill will pass in the Senate. The question is, will it pass in the House.

This promises to be a hectic, busy year. It's an election year! A lot of things will be done for the wrong reasons. Hopefully, some will be done for the right.


